### 1. Apologies

Cllr Firmston (on holiday), Cllr Glover (Covid), Cllr Taylor Absent: Cllr Churchill

### 2. Declarations of interest

- i. There were no declarations of interest for matters on the agenda
- ii. There were no dispensation requests

### 3. Minutes - to agree and sign the minutes of 16th February 2022 meeting

The minutes were proposed by Cllr Pocock, seconded by Cllr Campbell and with the following amendments were unanimously **AGREED** to be a true and accurate record and were duly signed by the Chair. Item 5iv: should read "proposed development on the boundary of West Wittering".

# 4. Public Question time from residents of Birdham in accordance with Standing Orders 1d - 11

A resident asked about the proposed development off Crooked Lane. The Clerk had written to CDC planning department about the site but had received no reply. It was confirmed that no council taxpayers money was being spent – all the funding was coming from Hyde. Cllr Hamilton said that it was being dealt with by CDC by Cllr Hamilton herself.

### 5. To receive a report from WSCC member for Birdham Cllr Montyn

- i. Cllr Montyn reported that the budget was passed last week by WSCC. The Operation Watershed funding is to be continued but with increased funding £300 £500K a year.
- ii. Cllr Montyn had attended the Appeal for Church Farm along with a number of local people. He said that the applicants fielded an ace team headed by Barrister Young; conversely the CDC team were not up to the mark. He had been in touch with Nicolas Bennet (CDC) about the S106 agreements as nobody seemed to know what was going on least of all the two women from WSCC. The public attending the appeal had put in a lot of effort to counter the application, something which CDC had not done. The applicants quoted "facilities for a town of 5000 people" lumping together East and West Wittering. Cllr Montyn said that Nottingham County Council partly owned Welbeck Strategic Land he was appalled that another county council was looking to build on local land and that CDC should take this up. Welbeck Land aims to promote planning applications in the south of England, signed by a senior office from Nottingham County Council and they have 75% controlling interest.

### 6. To receive reports from CDC members for Birdham

i. Cllr G Barrett had circulated the Members' bulletin to all councils.

- ii. Referring to the Church Lane appeal Cllr Barrett said that the decision would be made on 26<sup>th</sup> April.
- iii. With regard to the Local Plan CDC had delivered nearly twice as many homes as those required. Most of these go as second homes there is not a requirement for homes here.
- iv. There was to be a full council meeting on 15<sup>th</sup> March where all business would be discussed apart from the budget. The budget was discussed yesterday; there will be a £5 increase for Band D taxpayers
- v. CDC is finally going to employ a landscape officer. In this area CDC's performance has been quite poor. The officer will be employed on a two-year contract.

**i.** Cllr Hamilton informed the meeting that the CDC meeting next week required all questions to be sent in by noon on Friday.

# 8. Birdham Neighbourhood Plan Review to include report from CDC Panning Committee meeting Koolbergen Nurseries BI/20/02066/OUT

- a) Cllr Campbell reported that the last meeting was two weeks ago. The group has written to CDC saying that too many houses have been allocated to Birdham.
- b) Regarding the bequeathed land there has been a development in that the executors had not engaged with the council as to whether they would allow covenants to be removed. Cllr Glover spoke to one who is still practising and in contact with the other executors. They had potentially scope to change the covenants on the grounds that the bequest should not be a burden. If it could be shown to be of benefit to the Parish (financially) there would be grounds for a positive discussion. The group is looking at how many houses could be built and whether there would be a financial benefit. If there was a financial benefit and the beneficiaries and executors agree, a deed could remove the covenant.
  - Cllr Bush said that the worth needed to be established and whether it was viable. Cllr Glover said that the return had to be significant, or the executors would not release.
  - Cllr Pocock said that someone needed to establish how many homes could be built and to convince the executors money from the grant can be used for this.
- c) The draft design codes report: the group felt that it was just formulaic a template with a few bits added. They have made amendments and returned it. There is another meeting with the company next Tuesday.
- d) Cllr Campbell spoke at the Church Farm Appeal pointing out that the A286 was the busiest road emanating from Chichester and carries 50% more traffic than all other roads which pass through a village. It has also suffered 7 fatalities in 5 years.

## 9. Queen's Green Canopy Planting of Trees within Birdham – update and future care of saplings

The planting of a walnut tree will take place on Friday 11<sup>th</sup> March by the Vice Chair Elizabeth Hamilton to celebrate the 70<sup>th</sup> day of the 70<sup>th</sup> year of the reign of the Queen. It will be planted between the hall and the play area.

### 10. Harbour Conservancy Post - Councillor Bush

Cllr Bush had looked at the job description in detail and was unable to commit to the post. A councillor from W Wittering is applying Cllr Nicolette Pike. When CDALC issues the nominations, the council will decide who to support.

11. **Motion:** This Council supports the petition launched by Association of Democratic Government and Lawyers in Local Government on 5 January with regard to remote and hybrid meetings. We agree to write to the Secretary of State for Levelling Up, Housing and Communities calling on the Government to change the law to allow councils the flexibility to hold such meetings when they deem appropriate within agreed rules and procedures.

### 13. Councillor Reports:

  - most of the bequeathed land has been cleared.
  - The Scouts, Cubs, Beavers and Brownies of the 1st Birdham & Wittering group plus parents and residents spent the morning of the 5th March planting native tree whips under the supervision of Jane Reeve of the Manhood Wildlife and Heritage Group. There was a total of about 36 people involved. Their work will benefit the wildlife and make the playing field a more attractive area for residents. The work achieved will be used towards the Scouts Environment badge. It was agreed that a thank you letter should be sent to Jane Reeve and the Scouts.

- **iii. Manhood Peninsula Action Group** Cllr Glover reported that an MPAG meeting had taken place yesterday which discussed the appeal at Church Farm. The issue of the Welbeck Land Group and Nottingham County Council involvement (their pension investment group) was discussed. Louise Goldsmith had sent a letter saying that it was not ethical for a c to council to contribute to another council's planning development. They also sent a letter to the Boundary Review commission.

It was asked if BPC could write to Nottingham County Council and ask them how much they had earned from this?

Cllr Bush felt that although this was alarming, upsetting and disingenuous it was also a bit of a red herring. He said that it was distasteful and immoral but not illegal. The appeal would be interesting and 125 local people were there. The barrister was agreed to be obnoxious and questioning everything.

## 14. Reports of meetings attended by Councillors

Cllr Campbell and Mr David Thomson had met with two members of the Boxgrove Traffic Calming group. They were extremely helpful. They had gone to an enormous amount of trouble collecting data for Boxgrove- measuring speeds for several years. They said that just changing speed limits was not enough. Cllr Campbell is organising a meeting with Mike Thomas from WSCC. Cllr Campbell said that it was an extremely complicated business.
