Minutes of the of the Hybrid Parish Council Meeting held on Wednesday  $9^{\rm th}$  November 2022 at  $7\rm pm$

#### 1. Apologies

Cllr Glover Absent: Cllr Barrett Cllr Pocock

#### 2. Declarations of interest

- i. Cllr Salamons declared an interest for planning application 22/03034 as they lived opposite the site and had previously objected.
- ii. There were no dispensation requests

#### 3. Minutes - to agree and sign the minutes of 12th October 2022 meeting

The minutes were proposed by Cllr Devos, seconded by Cllr Campbell, and were unanimously **AGREED** to be a true and accurate record. They were duly signed by the Chairman.

# 4. Council thanks to Mr C Bush and approval of request to join neighbourhood Plan Review Group.

The chairman formally thanked Mr Clive Bush who had resigned from the Parish Council and whose in-depth planning knowledge had been invaluable to the council. Cllr Campbell proposed, and Cllr Hamilton seconded a formal vote of thanks. This was unanimously **AGREED**.

Cllr Churchill proposed accepting Mr Bush's request to join the Neighbourhood Plan Review Group. Seconded by Cllr Salamons and unanimously **AGREED.** 

The chairman said that there was now a good mix of councillors and residents in the review group.

## 5. Public Question time from residents of Birdham in accordance with Standing Orders 1d –

There were no questions.

#### 6. To receive a report from WSCC member for Birdham Cllr Montyn

- i. Cllr Montyn referred to the parking of ambulances at the village hall. He had asked for further information but to date had had no reply.
- ii. Cllr Montyn reported that from 3<sup>rd</sup> November there had been 158 hours of direct sewage discharge from Appledram wastewater treatment works. Tankers have been continuously operating from Pinks Lane pumping station in Birdham. A tanker has also been in use outside a private house in nearby Tawny Close. He had requested further information of Southern Water.
- iii. Cllr Montyn reminded the meeting of the Appeal hearing on  $22^{\rm nd}$  November for the development in Church Lane. He said that no mention of sewerage arrangements was in the planning application. He said that Southern Water will always say that there is not a problem, but Cllr Montyn disagreed. He will argue that it is not viable.
- iv. Cllr Montyn reported that the Boundary Commission had published its current proposals on redrawing the Chichester parliamentary constituency boundary and it would be open for further consultation. He said that Midhurst, Goodwood, Easebourne and the Loxwood area

- would go to Arundel and South Downs constituency. Pagham and Bersted would join the Chichester consituency. The plans were available on the Boundary Commission website.
- v. Cllr Montyn had forwarded the "Good" Ofsted report for Birdham Primary School following their recent inspection, and he said that they should be congratulated on this result.
- vi. The development of the West Sussex CC budget for the financial year 2023/2024 was awaiting the outcome of the Chancellor's Statement on the 17th November.

Cllr Campbell said that West Sussex Highways had refused the CHS scheme submitted by Birdham Parish Council but that they would like to discuss further certain elements of the scheme. A request for dates to meet for a discussion had been sent to them.

Cllr Churchill said that it wasn't so long ago that Birdham Primary School had been obliged to tender for Tesco tokens because they were so short of funds. Cllr Montyn said that WSCC distributes the central government block grant for the running costs of schools including Birdham and makes constant applications to the government for additional funding.

Cllr Hamilton said that Birdham Parish Council should write a letter of congratulations to the Head Teacher Mr Mark Adams.

Cllr Firmston asked Cllr Montyn if he could chase up the installation of the hardstanding for the Bell Lane bus stop. Mr Sam Pitwell WSCC Highways was dealing with it, and it was supposed to have been implemented a short while back.

#### 7. To receive reports from CDC members for Birdham

- i. Cllr Taylor said that Cllr Barrett had forwarded the members' bulletin.
- ii. Cllr Taylor said that CDC were making progress with the Local Plan and that it was anticipated that the plan would be submitted to Full Council and Cabinet (reg 19)in January. She said that it would then go to consultation and all comments passed to the examiner. She said that it was not possible to guarantee dates and that it was only a year ago that Natural England had announced no further development in the north until issues with water neutrality had been resolved.
  - The Council does not currently have a five-year housing land supply for 670 dwellings per annum based on the housing need required by the standard methodology. Evidence shows that the housing numbers required by the standard methodology are not achievable and CDC is looking at the possibility of a lower number. She said that once Reg 19 had been reached, even though the plan was not finalised, its policies would carry some weight and strengthen as the plan progresses.

Cllr Churchill asked how, in relation to the housing supply, does the council deal with the changing restrictions and regulations? There has been a lot of upset by wildlife and conservation groups because of the proposals that would slash the current protective restrictions. Cllr Taylor said that there were proposed changes, but they hadn't yet been passed.

Cllr Montyn said that the slides that were supposed to be attached to Cllr Barrett's email were not attached and not available. Cllr Taylor said that these slides were not available yet to the public and that Cllr Montyn should speak directly to Diane Shepherd.

#### CDC Cllr Elizabeth Hamilton

- **8.** Cllr Hamilton informed the meeting that CDC had started a new campaign dealing with the cost-of-living problems called 'Supporting You'. They were producing leaflets to inform people, and these could be distributed as freely as possible. She suggested that the village shop could take some and the Church will be displaying in porches and in café upstairs. Bracklesham Barn and the Medical centre will also have copies.

#### 10. Birdham Neighbourhood Plan Review report

- a) Cllr Campbell said that there was nothing to report whilst they awaited the updated housing numbers.

### 13. Councillor Reports:

#### i. Play area and playing field

- Cllr Firmston said that the slats around the play area (which had already been repaired but were now broken again) were to be mended by Lake Road Fencing and he was awaiting an estimate (and for around the village pond too).
- The safety harness for the swing for disabled children had been broken by a group of young people at the play area. They also broke the bridge. The council deplored such action by able bodied young people thereby depriving others of their playtime. The council is to re-order the harness and give into the keeping of a parent who needs it. Other playground repairs to be undertaken by Chris Milford.
- A notice explaining who is responsible for the play area to be fixed to the fence
- Cllr Firmston said that estimates for a Pirate ship/Galleon ranged from £47K to £12K. He felt that it might be too vulnerable to damage.

- Regarding the monkey bars the recommended age was 13+. He felt that it was not appropriate to have this age group in the playground area. A schedule of competitive quotes for other playground items was being complied.
- **ii. Village green and pond.** The working group of  $21^{st}$  October had been cancelled due to the storm with another group event planned for the  $12^{th}$  November.

Cllr Firmston had circulated a list of topics to be included. He hoped that it could be issued in early Spring.
